- 1. The closing date for applications is 26 January 2024. No late applications will be considered or accepted.
- 2. Applications will **ONLY BE CONSIDERED**, if submitted on the prescribed application form.
- 3. The below supporting documentation or attachments are COMPULSORY:
 - i. A copy of the Organization's **registration certificate**.
 - ii. A copy of the Organization's constitution.
 - iii. The latest **audited financial statements** (if latest year not reflected, statements for previous year should be submitted.
 - iv. A copy of the Organization's confirmation of banking details.
 - v. Copies of the Organization's last 12 months' bank statements.
 - vi. A copy of the latest municipal account.
- 4. No application will be considered unless the constitution contains a **dissolution clause** to the effect that in the event of the organization's dissolution, any remaining assets shall be handed over to an organization or society with similar objectives.
